

Ferret Software Ltd. (FSL)

SOFTWARE END USER LICENCE AGREEMENT

YOU ARE NOT AUTHORISED TO INSTALL OR USE THIS SOFTWARE UNTIL YOU HAVE AGREED TO THE TERMS OF THIS LICENCE.

Ferret, Dragitin Mapper, Dragitin, ScanWatcher, Ferret Tools for Outlook, Ferret Tools for Office, Ferret Time and Cost, Ferret Import Tool, Ferret Approval and Coding Tool (FACT), and Ferret File Launcher are Software packages developed and owned by FSL. In order to use any of these Software packages, you must be a licensee of FSL., which involves your agreement to the following terms. If you do not agree with these terms, the Software should not be installed and you must return the Software to FSL

Definition of Terms

- (a) "FSL" shall mean Ferret Software Ltd of 150 Puahue Road, RD5, Te Awamutu 3875, New Zealand, or any of its assigns.
- (b) "Software" shall mean all material relating to the Ferret, Drag It In Mapper, Drag It In, ScanWatcher, Ferret Tools for Outlook, Ferret Tools for Office, Ferret Time and Cost, Ferret Import Tool, ferret Approval and Coding Tool (FACT), and Ferret File Launcher programmes including, but not limited to source code, object code, interfaces, protocols, algorithms, documents, records, technical information, and similar material in any form whatsoever.
- (c) "Licensee" means the individual or entity that legally enters into this agreement.

On behalf of the licensee you represent, you agree as follows:

1. COPYRIGHT

- (a) The licensee acknowledges that the copyright in the Software in both source and object code form is owned by FSL.
- (b) THE LICENSEE shall not copy the Software in whole or in part except for the purposes of making a backup copy. The licensee will further not copy in whole or in part supporting documentation supplied with the Software.
- (c) CONFIDENTIAL INFORMATION - the Software design and concept is confidential and owned by FSL and the licensee agrees not to disclose, provide or otherwise make available any information relating to the Software or supporting documentation to any person other than employees for the specific use within your organisation without the prior written consent of FSL

2. TERMINATION –

- (a) FSL may terminate this licence by giving written notice to the licensee if the licensee fails to comply with any terms of this licence.

- (b) The licence may be terminated by the licensee giving one month's written notice to FSL. In the event of termination the licensee shall promptly return the Software and all documentation to FSL and any copies which may have been made.
- 3. **DISCLAIMER OF WARRANTY** - the Software is provided "as is". FSL makes no warranties either expressed or implied with respect to the Software or its merchantability or fitness for a particular purpose. Although every effort has been made to eliminate errors, FSL does not warrant that the Software is error free.
- 4. **MAINTENANCE & SUPPORT** - A mandatory Maintenance and Technical Support Agreement starts at the time of purchase, and is detailed in the separate FSL Maintenance & Technical Support Agreement document. Under the Terms of the Maintenance and Technical Support Agreement, you will be entitled to receive free modifications and upgrades to the Software so long as your payments of the Maintenance and Technical Support fees and/or subscriptions, which include the Maintenance and Technical Support fees, have been made. Please refer to the FSL Maintenance & Technical Support Agreement for details of the Terms and Conditions. In the event the FSL Maintenance and Technical Support Agreement or subscriptions are not renewed and appropriate fees paid, the Software will cease to operate, and your license to use the Software terminated.
- 5. **LIMITATION OF LIABILITY** - In no event shall FSL be liable for any direct, indirect or consequential damages including economic loss even if FSL has been advised of the possibility of such damage. The licensee agrees that any liability of FSL arising out of the use of the Software whether in contract or in tort shall not exceed the amount paid by the licensee for the Software involved.
- 6. FSL grants to the licensee, for whom you are an authorised officer, a non-transferable and non-exclusive licence to use the Software for its own use for the number of licenses that you have purchased. You acknowledge and agree that all rights, title and interest in and to the Software, including all intellectual property rights therein, are the property of FSL, subject only to the licences granted to you under this Agreement. This Agreement is not a sale and does not transfer to you any title or ownership in or to the Software.
- 7. **NON-TRANSFERABILITY** - You may not sell, rent, transfer, assign, sublicense or grant any licensing rights in the Software, in full or in part, to any other person or entity without FSL's written consent.
- 8. **TERM** - This licence is effective from the date on which the licensee installs the Software and shall remain in force until terminated by FSL or the licensee.
